Operations Committee Chair, Gostin welcomed everyone to the first meeting of the year and said that the committee would be scheduling the remaining 2022 meetings soon. The full schedule of 2022 meetings will be made available to everyone once confirmed.

During 2022, each MGA Committee Chair will be asked to provide a report to OpCom at some point during the year.

MGA Priority Projects were reviewed, followed by the Treasurers report on 2021 finances, the 2022 budget, the 2023 budgeting timeline, and NextGen. One of the Priority Projects, Hybrid Resources, was discussed in more detail. Several motions were then presented, discussed and voted, with all being passed:

- ▶ **RESOLVED** that the MGA Operations Committee endorses the creation of an MGA Chapter Operations Support Committee as a committee of the MGA Geographic Unit Operations Support Committee as presented pending the incorporation of feedback from IEEE Governance.
- **RESOLVED** that the MGA Operations Committee endorses the changes to Sections 2.10, 4.22 and the addition of Section 2.11 as presented.
- ► **RESOLVED** that the MGA Operations Committee endorses the MGA Operations Manual Compliance working group to continue in 2022 to complete the necessary governance changes within the MGA Operations Manual.
- ▶ **RESOLVED** that the MGA Operations Committee endorses the IEEE Member Group Term Life Insurance policy (the Plan) premium credit reduction from 20 percent to 10 percent effective 1 September 2022, for the billing period 1 September 2022 through 28 February 2023.
- ► **RESOLVED** that the MGA Operations Committee endorses the implementation plan as detailed below for the provision of appointing up to two adjunct committee members to MGA committees:
  - MGA Committees exempted from this change:
    - Nominations & Appointments Committee
    - Admission & Advancement Committee
    - Conflict Resolution Committee (-> new name)
    - Awards & Recognition Committee
    - Finance Committee
    - Strategic Planning Committee
    - Operations Committee
    - Adjunct Committee members be appointed to various MGA committees in a pilot mode in 2022 and 2023
  - Required updates to the MGA Operations Manual be prepared for Governance Review
